

Terms and conditions of the ICOMI prize draw

1. Organisers of the Draw

2. Eligibility

The prize draw is open to all health professionals, researchers or undergraduate, master's or doctoral students in health science-related careers.

3. Prize

The prize offered is a free registration to attend the virtual 2nd International Congress of Micro-immunotherapy (hereinafter, ICOMI) which will be celebrated from 2 to 4 June 2022.

4. How to participate

In order to participate in the draw, the following requirements must be met:

1. Follow any of the ICOMI Organising Associations on one of their social networks.
2. Follow ICOMI in any of the social networks in which it is present (LinkedIn, Facebook, Twitter).
3. Like the publication related to this draw.

5. Deadline for participation

The deadline to participate in the draw starts on 1 April 2022 at 00:00 hours and ends on 22 April 2022 at 00:00 hours.

The draw will take place on 25 April 2022

6. Number of winners

The draw will have a total of three (3) winners. The prize offered for each winner is one free registration to attend ICOMI.

7. Draw and winner announcement

The winners will be chosen randomly using a mathematical formula in Google Sheets. Participants will be able to watch the video in which the winners are chosen in the link that will be inserted in the social media post announcing the winners.

In the event that the winner of the draw has previously registered to attend ICOMI, the Organisers will refund the amount corresponding to one registration and the winner will not receive any additional registration.

The Associations will contact the winners by private message on social media. If a winner does not respond to the Associations within 14 days of being notified, then the winner's prize will be forfeited and the Associations will be entitled to select another winner in accordance with the process described above.

In order to attend ICOMI, a link will be sent to the winner by email for free registration.

The prize is non-exchangeable, non-transferable and no cash alternative is offered.

The decision of the Associations regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

The name of the winners of the draw will be published on ICOMI's social media on 25 April 2022.

8. Limitation of liability

The Associations reserve the right to hold void, cancel, suspend, or amend the prize draw or amend these terms and conditions at any time, without prior notice.

9. Acceptance of the terms and conditions

By entering the prize draw the participants are agreeing to these prize draw terms and conditions.
